

Dayton Hamvention® Flea Market Application Form

Welcome to the Dayton Hamvention® 2012.

The Dayton Hamvention® 2012 will be held on May 18-20 with unassisted installation of your displays on Thursday May 17, 8 a.m. until midnight and on Friday May 18 and Saturday May 19 from 6:00-7:30 a.m. Dismantling will take place on May 20, from the time the displays close until 8 p.m. Any other times require approval of the Flea Market Committee. Visit <http://www.hamvention.org> for updated show times.

The Flea Market vendor space cost will not be changing this year. All Flea Market vendor spaces will be \$70.00 per space, end of aisle spaces are \$100.00.

Ham Radio Club's can rent 4 spaces, in a row or front to back (not end spaces) for \$100.00. When sending in payment we would also require proof of club, like a license, newsletter or letterhead. Please do not pay online; the Flea Market Committee will have to adjust the prices before payment.

There is a maximum of two Flea Market Vendor Admission tickets per Flea Market space (**Vendor Tickets are not included and must be purchased for space rentals**). If more than two tickets per space are needed, you must then purchase General Admission tickets. For Vendors with crews holding General Admission, they can gain access for setup and teardown while being escorted by a Vendor holding ticket.

A Space Pass is required with each vehicle for entry/exit from the flea market area and a minimum of one is included with a space rental.

The approximate size of each Flea Market space is 9 x 17 feet or 153 square feet. You must park any vehicle that extends into the pedestrian aisle in the courtesy lot on the west end of the Flea Market. See the Dayton Hamvention® 2012 Flea Market Rule Sheet. **You are allowed one Courtesy Parking Pass per space order. Parking is on a First Come, First Serve basis.**

This order form is good for ordering up to eight Flea Market spaces. Please use the accompanying forms to request your spaces for 2012. If requesting more than eight spaces, do not fill in prices until you have contacted the Flea Market Committee.

We use the prefix of "FW" for Flea Market-West and "FE" for Flea Market-East to make finding vendor sites easier. The numbers following the prefix will stay the same as previous years, e.g., FW 2317 or FE 2008.

Please be sure to review the Ohio Tax Letter located at www.tax.ohio.gov and in the Hamvention group at Yahoo (<http://groups.yahoo.com/group/hamvention/>) and the Dayton Hamvention® 2012 Flea Market Rules, at the end of this document.
